Section 4: FIRST AID MEASURES

- Eye Contact:** In case of contact, immediately flush eyes with plenty of water. If easy to do, remove contact lenses, if worn.

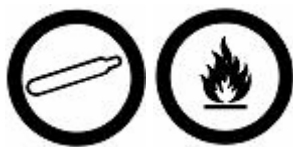
