5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Water spray, all-purpose dry chemical, CO₂.

SPECIAL FIRE FIGHTING PROCEDURES: FLAMMABLE/COMBUSTIBLE material. May be ignited by heat, sparks, and

flame. Vapors may travel to a source of ignition and flash back. Fires may produce irritating or poisonous fumes. Self-contained breathing apparatus and protective clothing should be worn when fighting chemical fires. Move containers from fire area if it can be done without risk.
