3. HAZARDS IDENTIFICATION

POTENTIAL HEALTH EFFECTS

- EYE CONTACT:** Corrosive. Causes burns resulting in permanent injury to eyes including blindness.

4. FIRST AID MEASURES

INHALATION: Remove victim to fresh air. Give oxygen, if needed. Get medical attention immediately.
