### **SECTION 2: HAZARD IDENTIFICATION**

#### EMERGENCY OVERVIEW

WARNING: This product is a white cream with a lemon or lavender fragrance. Direct contact with eyes can cause irritation. Ingestion of large amounts may cause some gastrointestinal discomfort including nausea, vomiting and diarrhea. Repeated or prolonged contact with skin may cause irritation or dermatitis. ### **SECTION 4: FIRST AID MEASURES**
