## **SECTION 2: HAZARD IDENTIFICATION**

#### EMERGENCY OVERVIEW

CAUTION: This product is clear, colored fragranced beads. Direct contact with eyes may cause irritation. Ingestion of large quantities may be harmful. ## **SECTION 4: FIRST AID MEASURES**
