## 2. HAZARDS IDENTIFICATION

#### **EMERGENCY OVERVIEW**

Skin contact:

## 4. FIRST AID MEASURES

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and
